#### f. JCB Backhoe Purchase

As part of the 2023-24 approved capital plan, the district is purchasing a backhoe, to replace the 2001 JCB backhoe. N&S Tractor is the only JCB distributor in our area per the JCB website. The width of the JCB backhoe is needed in order to get down our cemetery plot rows, eliminating our ability to look at other tractor brands. Additionally, we dig at double depth, requiring the specialized JCB arm. JCB is the only 4-wheel steer/ 4-wheel drive backhoe, also allowing us to dig at difficult angles.
